


## Total U.S. Exports of 600-Series and 9x515 Items

U.S. exports of 600-Series and 9x515 items from October 15, 2013 to June 30, 2018 totaled 437,642 shipments<sup>1</sup> for approximately \$30.2 billion.




U.S. Exports of 600-Series and 9x515 Items by Shipment Count Effective Date to June 30, 2018

Of the \$30.2 billion in U.S. exports of 600-Series and 9x515 items from October 15, 2013 to June 30, 2018, \$28.2 billion (93.6% of the total) was shipped under BIS jurisdiction; and \$2.0 billion (6.4%) was shipped under DDTC jurisdiction<sup>2</sup>.

## U.S. Exports of 600-Series Items under BIS Authorization

Of the \$28.2 billion in U.S. exports under BIS jurisdiction from October 15, 2013 to June 30, 2018:

- ▶ \$21.5 billion were for 600-series items; and
- $\blacktriangleright$  \$6.7 billion were for 9x515 items.


Of the \$21.5 billion in U.S. exports under BIS jurisdiction for 600-sereis items, the top 15 destinations were Japan with \$3.7 billion (17.2% of the total value), Canada with \$2.3 billion (10.6%) and United Kingdom with \$2.2 billion (10.3%).

Of the \$21.5 billion in U.S. exports of 600-series items under BIS jurisdiction from October 15, 2013 to June 30, 2018, licensed exports totaled \$9.8billion (49.1% of the total); STA totaled \$2.5 billion (12.5%); and RPL totaled \$2.2 billion (10.9%).

LVS: Shipments of limited value
