

The Fifth Rule of USML to CCL Regulatory Change Military Electronics December 30, 2014 to December 31, 2020

Since the fifth rule of the USML to the CCL regulatory change became effective on December 30, 2014 to December 31, 2020, BIS has processed a total of 18,153 applications for a value of \$25.8 billion for the eight 600-Series items created by this rule. The average number of BIS license applications is 252 per month. BIS has approved 16,066 licenses for a value of \$23.3 billion and the approval rate is 88.5%




From the effective date of December 30, 2014 to December 31, 2020, U.S. exports of items in the Fifth USML to CCL regulatory change – Military Electronics items (3y611 and 9y620) under BIS jurisdiction totaled 74,502 shipments with a value of \$5.1 billion.

Of \$5.1 billion in U.S. exports of 600-series items under the Fifth rule of the USML to the CCL regulatory change under BIS jurisdiction from December 30, 2014 to December 31, 2020, licensed exports totaled \$2.1 billion (41.6% of the total); Strategic Trade Authorization (STA) totaled \$1.2 billion (22.8%) and Governments and international organizations (GOV) totaled \$561.3 million (11.0%).



BIS License Exceptions:

STA: Strategic Trade Authorization

RPL: Servicing and replacement of parts and equipment

GOV: Governments, international organizations, international inspections under the Chemical Weapons

Convention, and the International Space Station

NLR: No License Required

TMP: Temporary imports, exports, reexports, and transfers (in-country)
