

U.S. Trade with Spain

Summary

In 2021, U.S. exports to Spain totaled \$16.1 billion, a 24.9% (\$3.2 billion) increase from 2020; U.S. imports from Spain totaled \$18.6 billion, a 21.5% (\$3.3 billion) increase; and the trade deficit was \$2.5 billion, a 3.6% (\$89.3 million) increase.

In 2021, 0.9% of the total U.S. exports were shipped to Spain while 0.7% of total U.S. Imports were delivered from Spain.

From 2020 to 2021, three out of four of the top commodity sectors of the U.S. exports to Spain increased in absolute terms. In 2021, U.S. exports of Chemicals, Plastics, and Leather goods increased by 59.8% (\$1.9 billion) from \$3.2 billion in 2020 to \$5.1 billion. Oils, Minerals, Lime, and Cement exports increased by 53.2% (\$1.5 billion) from \$2.9 billion to \$4.4 billion. Agricultural goods saw a rise of 9.8%, increasing from \$1.5 billion in 2020 to \$1.6 billion in 2021. Stone, Glass, and Metals and Pearls sectors experienced the largest increase in terms of percentage change, nearly doubling in absolute value from \$67.7 million in 2020 to \$128.7 million in 2021, increased by 90.0%.

In 2021, the U.S. imported \$399.4 million worth of Art, Collectors' Pieces, and Antiques from Spain, representing 4.8% of the global U.S. imports of those commodities.

In 2021, U.S. exports to Spain shipped under a BIS license exception authorization totaled \$100.8 million, increasing from \$95.1 million in 2020. Usage of the license exception authorization for Encryption Commodities & Software was \$62.3 million in 2021, an increase from \$58.7 million in 2020.

In 2021, BIS reviewed 536 export/re-export license applications (not including deemed export applications) for tangible items, software and technology valued at \$802.4 million for Spain. BIS approved 488 (91.0% of the total applications) for \$763.3 million, RWA totaled 47 for \$39.1 million and there was one denied license application. In 2021, license applications for Spain counted 1.3% of the World total by license count.

In 2021, BIS approved five applications from Spanish nationals for deemed exports, there was one RWA and no denials. In 2021, license applications for deemed export from Spanish nationals counted 0.6% of all applications for deemed exports from all destinations.

In 2021, the top approved ECCNs, including ECCNs for deemed exports, were **9A610** for Military aircraft and related commodities with 120 approvals; **3A611** for Military electronics with 86 approvals; and **3A001** Electronic items, with 37 approvals.

In 2021, the average processing time for Spain was 23 calendar days.



U.S. Trade with Spain

I. Total U.S. Trade in goods with Spain

In 2021, U.S. exports to Spain totaled \$16.1 billion, a 24.9% (\$3.2 billion) increase from 2020; U.S. imports from Spain totaled \$18.6 billion, a 21.5% (\$3.3 billion) increase; and the trade deficit was \$2.5 billion, a 3.6% (\$89.3 million) increase.

In 2021, the level of both U.S. exports to Spain and U.S. imports from Spain exceeded the prior five-year average level by value not adjusted for inflation. The U.S. trade surplus with Spain is lower than the prior five-year average level by value not adjusted for inflation.

U.S. Trade with Spain

In 2021, of the \$16.1 billion in U.S. exports to Spain, the top commodity sectors were Chemicals, Plastics, Rubber and Leather products (31.5%), Oils, Minerals, Lime, Cement (27.6%), Agricultural goods (10.1%), and Machinery and Mechanical Appliances (10.1%).

In 2021, of the \$18.6 billion in U.S. imports from Spain, the top commodity sectors were Chemicals, Plastics, Rubber and Leather products (26.8%), Machinery and Mechanical Appliances (19.7%), and Agricultural goods (14.5%).

In 2021, $\underline{0.9\%}$ of the total $\underline{U.S.\ exports}$ were shipped to Spain while $\underline{0.7\%}$ of total $\underline{U.S.\ Imports}$ were delivered from Spain.

U.S. Exports to Spain

In 2021, Machinery and Mechanical Appliances decreased by 2.0%, from \$1.7 billion to \$1.6 billion.

U.S. Imports from Spain

In 2021, the U.S. imported \$399.4 million worth of Art, Collectors' Pieces, and Antiques from Spain, representing 4.8% of the global U.S. imports of those commodities.



In 2021, of the \$16.1 billion in U.S. exports to Spain:

- 1.1% were subject to a BIS license requirement.
 - o 0.5% were exported under a BIS license. Worldwide, 0.4% were exported under a BIS license.
 - o 0.6% were exported under a BIS license exception. Worldwide, 0.8% were exported under a BIS license exception.
- 5.4% were exported under No License Required with an ECCN; Worldwide, 10.0% were exported under NLR with an ECCN reported.
 - o 0.02% were exported under NLR for 600-series .y subparagraph items. Worldwide, 0.02% were exported under NLR 600-series .y subparagraph items.
 - o 0.001% were exported under NLR for 0A501 .y subparagraph Firearms items; Worldwide, 0.001% were exported under NLR for 0A501 .y subparagraph Firearms items.






U.S. Exports to Spain subject to U.S. Government Export Control

In 2021, U.S. exports to Spain shipped under a BIS license exception totaled \$100.8 million, a 5.9% (\$5.6 million) increase from 2020.


U.S. Exports under BIS License Exceptions to Spain (\$millions)

In 2021, the top license exception Encryption Commodities & Software (ENC) totaled \$62.3 million (61.8% of all license exceptions), followed by Servicing & Replacement of Parts & Equipment (RPL) at \$24.1 million (23.9%), and Strategic Trade Authorization, totaling \$6.5 million (6.5%)









BIS License Determination Trends for Spain

III. BIS Licensing to Spain

In 2021, BIS reviewed 536 export/re-export applications (not including deemed export applications) valued at \$802.4 million for Spain, out of a total of 39,901 applications worldwide for tangible items, software and technology valued at \$1.4 trillion.

- Approved applications for Spain totaled 488 (91.0% of the total applications) for \$763.3 million, compared to 34,369 (86.1%) approved applications for all destinations valued at \$322.8 billion.







BIS License Determination Trends for Spain

In 2021, BIS reviewed 6 applications for Deemed Exports from Spanish nationals, out of 942 applications worldwide for deemed exports. Five applications were approved (83.3%), compared to the 821 (87.2%) approved applications for all destinations. One application was returned without action (RWA).

In the last five years, there were no denials for Deemed Export applications from Spanish nationals.
