
U.S. Exports of 600-Series, 9x515, Firearms Items under BIS Authorization

U.S. exports of 600-Series, 9x515, and firearms items from October 15, 2013 to December 31, 2022 totaled 1,036,414 shipments¹ for approximately \$64.6 billion under BIS authorization.

U.S. Exports of 600-Series, 9x515 & Firearms Items under BIS Authorization by Value


Effective Date to December 31, 2022 \$million

¹ Shipments are defined as exports being sent from one order party to one consignee located in a single country of destination on a single conveyance on the same day.

Of \$64.6 billion in U.S. exports of 600-series items, 9x515 items, and firearms items under BIS jurisdiction from October 15, 2013 to December 31, 2022:

- > \$50.0 billion were for 600-series items; and
- > \$11.9 billion were for 9x515 items.
- > \$2.6 billion were for firearm items.

Of \$53.6 billion in U.S. exports under BIS jurisdiction for 600-series items, the top 3 destinations were Japan with \$8.6 billion (17.2% of the total value), Canada with \$4.8 billion (9.6%) and the United Kingdom with \$4.6 billion (9.3%).


Of \$50.0 billion in U.S. exports of 600-series items under BIS jurisdiction from October 15, 2013 to December 31, 2022, the ECCN with the top export value was 9A610 for military aircraft and related commodities created by the first USML to CCL regulatory change.

Second was ECCN 9A619 for military gas turbine engines and related commodities, also created by the first USML to CCL regulatory change.

Third was ECCN 3A611 for military electronics created by the fifth USML to CCL regulatory change.

Of \$50.0 billion in U.S. exports of 600-series items under BIS jurisdiction from October 15, 2013 to December 31, 2022, licensed exports totaled \$24.7 billion (50.7% of the total); STA totaled \$6.4 billion (13.2%); and RPL totaled \$5.0 billion (10.3%).

RPL: Servicing and replacement of parts and equipment

NLR: No License Required

GOV: Governments, international organizations, international inspections under the Chemical Weapons

Convention, and the International Space Station

TMP: Temporary imports, exports, reexports, and transfers (in-country)

LVS: Shipments of limited value
