

Analysis of U.S. Trade with Turkey, 2022

Summary

Imports and exports reported by U.S. Census Bureau¹

In 2022, both U.S. exports to Turkey and imports from Turkey continued to grow for a second year in a row. U.S. exports totaled \$15.2 billion, an increase of 27.4% (\$3.3 billion), and U.S. imports totaled \$18.8 billion, an increase of 18.6% (\$3.0 billion). The trade deficit was \$3.6 billion, decreasing 7.8% (\$307.5 million) from 2021.

In 2022, 0.7% of total U.S. global exports of \$2.1 trillion were exported to Turkey and 0.6% of total U.S. imports of \$3.2 trillion from all countries were imported from Turkey.

In 2022, \$3.7 billion of U.S. exports of Oils, Minerals, Lime, Cement to Turkey represented 1.0% of U.S. global exports of those commodities.

In 2022, \$3.0 billion of U.S. imports Of Textiles, Footwear, Headgear from Turkey constituted 1.6% of the total U.S. imports of those commodities.

BIS export data²

In 2022, U.S. exports to Turkey made under a BIS license exception totaled \$95.7 million, an increase of 6.4% from \$89.9 million in 2021.

In 2022, the top license exception utilized under the Export Administration Regulations (EAR) was Encryption Commodities & Software (ENC), totaled at \$64.6 million (67.5% of all license exceptions for Turkey), followed by Strategic Trade Authorization (STA), totaled at \$17.4 million (18.2%), and Servicing & Replacement of Parts & Equipment (RPL), totaled at \$8.1 million (8.5%).

BIS licensing data³

In 2022, the number of export license applications for Turkey, excluding applications for deemed exports and reexports, amounted to 2.5% of total applications worldwide.

In 2022, for applications involving commodities, software, and technology (excluding deemed exports and reexports of technology and source code to Turkish nationals in the U.S. or in a third country), BIS reviewed 971 export/re-export license applications valued at \$1.5 billion for Turkey. BIS denied only two license applications. BIS approved 854 applications valued at \$1.4 billion with an approval rate of 88.0%. 115 license applications were returned without action (RWA).

In 2022, BIS reviewed 1 application for deemed exports or reexports involving Turkish nationals, representing 0.1% of total deemed export or reexport applications worldwide. BIS approved this application (an approval rate of 100%).⁴

In 2022, the top approved ECCNs on licenses for Turkey were 0A501 for Firearms (except 0A502 shotguns) and related commodities with 339 approvals, followed by 9A610 for Military Aircraft and Related Commodities with 179 approvals, and 0A505 for Ammunition with 146 approvals.

In 2022, the average processing time for applications involving Turkey was 31 calendar days.



I. Total U.S. trade in goods with Turkey⁵

In 2022, both U.S. exports to Turkey and imports from Turkey continued to grow for a second year in a row. U.S. exports totaled \$15.2 billion, an increase of 27.4% (\$3.3 billion), and U.S. imports totaled \$18.8 billion, an increase of 18.6% (\$3.0 billion). The trade deficit was \$3.6 billion, decreasing 7.8% (\$307.5 million) from 2021.



In 2022, the level of U.S. exports to Turkey and U.S. imports from Turkey in goods, merchandise, and commodities as well as the trade deficit with Turkey all exceeded the prior five-year average level by value (not adjusted for inflation).

In 2022, of \$15.2 billion in U.S. exports to Turkey, the top commodity sectors were Oils, Minerals, Lime, Cement (24.5% of the total exports to the country), Transportation Equipment (16.3% of such total), and Chemicals, Plastics, Rubber, and Leather Goods (14.3% of such total).

In 2022, of \$18.8 billion in U.S. imports from Turkey, the top commodity sectors were Textiles, Footwear, Headgear (15.7% of the total U.S imports from the country), Base Metals, Iron, Steel, Tools (13.4% of such total) and Stone, Glass, Metals, Pearls (12.5% of such total).

In 2022, 0.7% of total U.S. global exports of \$2.1 trillion were exported to Turkey and 0.6% of total U.S. imports of \$3.2 trillion from all countries were imported from Turkey.

Exports

In 2022, \$3.7 billion of U.S. exports of Oils, Minerals, Lime, Cement to Turkey represented 1.0% of U.S. global exports of those commodities. Additionally, \$2.5 billion of exports of Transportation Equipment represented 1.0%, and \$2.2 billion of Chemicals, Plastics, Rubber, And Leather Goods represented 0.6% of U.S. global exports of those commodities.

Imports

In 2022, \$3.0 billion of U.S. imports of Textiles, Footwear, Headgear from Turkey constituted 1.6% of the total U.S. imports of those commodities. Additionally, \$2.5 billion of imports of Base Metals, Iron, Steel, Tools represented 1.3%, and the \$2.4 billion of imports of Stone, Glass, Metals, Pearls represented 1.9% of the global U.S. imports of those commodities.

II. U.S. Exports to Turkey Subject to BIS Export Controls⁶

In 2022, of the \$15.2 billion⁷ in U.S. exports to Turkey:

- \$110.4 million, or 0.7% of the total value, were exported under a BIS license;
- \$95.7 million, or 0.6% of the total value, were exported under a BIS license exception;
- \$2.4 billion, or 15.5%, were exported under No License Required (NLR) reporting an ECCN⁸;
- \$3.2 million, or 0.02%, were exported under NLR for 600-series. y subparagraph items⁹;
- \$960, or 0.00001%, were exported under NLR for 0A501. y subparagraph Firearms items.¹⁰

For comparison, globally:

- 0.4% of U.S. exports by dollar value were exported under a BIS license;
- 0.8% were exported under a BIS license exception;
- 9.6% of exports were exported under NLR reporting an ECCN;
- 0.02% of exports were exported under NLR for 600-series. y subparagraph items;
- 0.001% of exports were exported under NLR for 0A501. y subparagraph Firearms items.





RPL: Servicing and replacement of parts and equipment





In 2022, U.S. exports to Turkey shipped under BIS license exception ENC totaled \$64.6 million, a 23.7% increase from \$52.2 million in 2021.



III. BIS Licensing Involving Turkey¹¹

In 2022, the number of export license applications for Turkey, excluding applications for deemed exports and reexports, amounted to 2.5% of total applications worldwide.


In 2022, for applications involving commodities, software, and technology (excluding deemed exports and reexports of technology and source code to Turkish nationals in the U.S. or in a third country), BIS reviewed 971 export/re-export license applications valued at \$1.5 billion for Turkey, compared to 39,045 applications worldwide valued at \$335.9 billion. BIS denied only two license applications. BIS approved 854 applications valued at \$1.4 billion with an approval rate of 88.0%, compared to 34,068 approvals worldwide and valued at \$226.1 billion with an approval rate of 87.3%.
