

Analysis of U.S. Trade with UAE, 2022

Summary

Imports and exports reported by U.S. Census Bureau¹

In 2022, both U.S. exports to the United Arab Emirates (UAE) and imports from UAE grew significantly compared to 2021. U.S. exports totaled \$20.8 billion, an increase of 22.2% (\$3.8 billion), and U.S. imports totaled \$6.9 billion, an increase of 10.0% (\$628.1 million). The trade surplus was \$14.0 billion, increasing 29.2% (\$3.1 billion) from 2021.

In 2022, 1.0% of total U.S. global exports of \$2.1 trillion were exported to UAE and 0.2% of total U.S. imports of \$3.2 trillion from all countries were imported from UAE.

In 2022, \$6.5 billion of U.S. exports of Transportation Equipment to UAE represented 2.7% of U.S. global exports of those commodities.

In 2022, \$2.5 billion of U.S. imports of Base Metals, Iron, Steel, Tools from UAE constituted 1.3% of the total U.S. imports of those commodities.

BIS export data²

In 2022, U.S. exports to UAE made under a BIS license exception totaled \$226.8 million, a decrease of 23.3% from \$295.5 million in 2021.

In 2022, the top license exception, Encryption commodities, software, and technology (ENC), totaled at \$122.8 million (54.2% of all license exceptions for UAE), followed by Servicing and replacement of parts and equipment (RPL), totaled at \$80.8 million (35.6%), and Temporary imports, exports, reexports, and transfers (in-country) (TMP), totaled at \$16.6 million (7.3%).

BIS licensing data³

In 2022, the number of export license applications for UAE, excluding applications for deemed⁴ exports, amounted to 1.7% of total applications worldwide.

In 2022, for applications involving commodities, software, and technology (excluding deemed exports and reexports of technology and source code to Emirati nationals in the U.S. or in a third country), BIS reviewed 673 export/re-export license applications valued at \$1.3 billion for UAE. BIS denied 8 license applications. BIS approved 591 applications valued at \$1.2 billion with an approval rate of 87.8%. 74 applications were returned without action (RWA).

In 2022, BIS reviewed 2 applications for deemed exports or reexports involving Emirati nationals, representing 0.1% of total deemed export or reexport applications worldwide. BIS approved 1 of these applications and returned 1 without action (an approval rate of 50%).

In 2022, the top approved ECCNs on licenses for UAE were 9A610 for Military Aircraft and Related Commodities with 147 approvals, followed by 0A501 for Firearms (except 0A502 shotguns) and related commodities with 67 approvals, and 6A003 for Cameras, Systems or Equipment, and "Components" with 55 approvals.

In 2022, the average processing time for applications involving UAE was 32 calendar days.

I. Total U.S. trade in goods with UAE⁵

In 2022, both U.S. exports to UAE and imports from UAE grew significantly compared to 2021. U.S. exports totaled \$20.8 billion, an increase of 22.2% (\$3.8 billion), and U.S. imports totaled \$6.9 billion, an increase of 10.0% (\$628.1 million). The trade surplus was \$14.0 billion, increasing 29.2% (\$3.1 billion) from 2021.



In 2022, the level of U.S. exports to UAE and U.S. imports from UAE in goods, merchandise, and commodities as well as the trade deficit with UAE all exceeded the prior five-year average level by value (not adjusted for inflation).

In 2022, of \$20.8 billion in U.S. exports to UAE, the top commodity sectors were Transportation Equipment (31.0% of the total exports to the country), Machinery & Mechanical Appliances (30.9% of such total), and Stone, Glass, Metals, Pearls (8.5% of such total).

In 2022, of \$6.9 billion in U.S. imports from UAE, the top commodity sectors were Base Metals, Iron, Steel, Tools (35.7% of the total U.S imports from the country), Oils, Minerals, Lime, Cement (26.9% of such total) and Special Classification Items (14.1% of such total).

In 2022, 1.0% of total U.S. global exports of \$2.1 trillion were exported to UAE and 0.2% of total U.S. imports of \$3.2 trillion from all countries were imported from UAE.

Exports

In 2022, \$6.5 billion of U.S. exports of Transportation Equipment to UAE represented 2.7% of U.S. global exports of those commodities. Additionally, \$6.4 billion of exports of Machinery & Mechanical Appliances represented 1.5%, and \$1.8 billion of Stone, Glass, Metals, Pearls represented 1.7% of U.S. global exports of those commodities.

Imports

In 2022, \$2.5 billion of U.S. imports of Base Metals, Iron, Steel, Tools from UAE constituted 1.3% of the total U.S. imports of those commodities. Additionally, \$1.9 billion of imports of Oils, Minerals, Lime, Cement represented 0.6%, and \$973.8 million of imports of Special Classification Items represented 1.0% of the global U.S. imports of those commodities.

II. U.S. Exports to UAE Subject to BIS Export Controls⁶

In 2022, of the \$20.9 billion⁷ in U.S. exports to UAE:

- \$254.3 million, or 1.2% of the total value, were exported under a BIS license;
- \$226.8 million, or 1.1% of the total value, were exported under a BIS license exception;
- \$3.7 billion, or 17.9%, were exported under No License Required (NLR) reporting an ECCN⁸;
- \$8.0 million, or 0.04%, were exported under NLR for 600-series. y subparagraph items⁹;
- \$318,348, or 0.002%, were exported under NLR for 0A501. y subparagraph Firearms items. 10

For comparison, globally:

- 0.4% of U.S. exports by dollar value were exported under a BIS license;
- 0.8% were exported under a BIS license exception;
- 9.6% of exports were exported under NLR reporting an ECCN;
- 0.02% of exports were exported under NLR for 600-series. y subparagraph items;
- 0.001% of exports were exported under NLR for 0A501. y subparagraph Firearms items.





TMP: Temporary imports, exports, reexports, and transfers (in-country)







III. BIS Licensing Involving UAE¹¹

In 2022, the number of export license applications for UAE, excluding applications for deemed exports and reexports, amounted to 1.7% of total applications worldwide.

In 2022, for applications involving commodities, software, and technology (excluding deemed exports and reexports of technology and source code to Emirati nationals in the U.S. or in a third country), BIS reviewed 673 export/re-export license applications valued at \$1.3 billion for UAE, compared to 39,045 applications worldwide valued at \$335.9 billion. BIS denied 8 license applications. BIS approved 591 applications valued at \$1.2 billion with an approval rate of 87.8%, compared to 34,068 approvals worldwide and valued at \$226.1 billion with an approval rate of 87.3%.


