**“Encryption Controls”**

This full day program is an in-depth session that will focus on the unique provisions related to encryption under the Export Administration Regulations (EAR). BIS licensing officers will provide a comprehensive overview of controls on encryption in the EAR, including what items are and are not controlled in Category 5 Part 2, License Exception ENC and mass market provisions (740.17), and encryption classification and licensing.

**Prerequisite:** The prerequisite for this course is the completion of the Complying with U.S Export Controls Seminar or equivalent experience.

**Instructors:** The instructors are experienced export policy specialists from BIS' Information Technology Division in Washington D.C. The instructors will be available throughout the seminar to answer your questions on how the export regulations affect the export activities of your organization or client.

**Location/Time:** The program will be held at the Sonesta San Jose-Milpitas Hotel, 777 Bellew Drive, Milpitas, CA 95035. Registration will begin at 7:30am. The program begins at 8:30am and ends at 4:30pm.
