
II. STA Shipments


From July 2011 - December 2016, there were 33,185 shipments exported under STA license exception. Of these shipments, 10,469 (31.5 percent) were less than \$2,500.




Of the 44 countries eligible for shipments under the STA license exception, two countries have not been recipients of STA shipments: Albania and Malta.

III. 600-Series and 9x515 STA Exports

From October 2013 – December 2016, there were 21,634 exports of 600-series and 9x515 items under the STA license exception worth \$2.0 billion by 597 exporters (70.3 percent of all STA users).

• 11 of the 14 new STA users for December 2016 only exported 600-series items.

IV. STA Ultimate Consignees

From July 2011 - December 2016, there were 4,886 ultimate consignees that received items exported under the STA license exception.

- Of these ultimate consignees, 3,257 (66.7 percent) received one-time shipments.
- 362 ultimate consignees received ten or more shipments under the STA license exception.
- 997 ultimate consignees received 600-series and 9x515 items under the STA license exception.
