

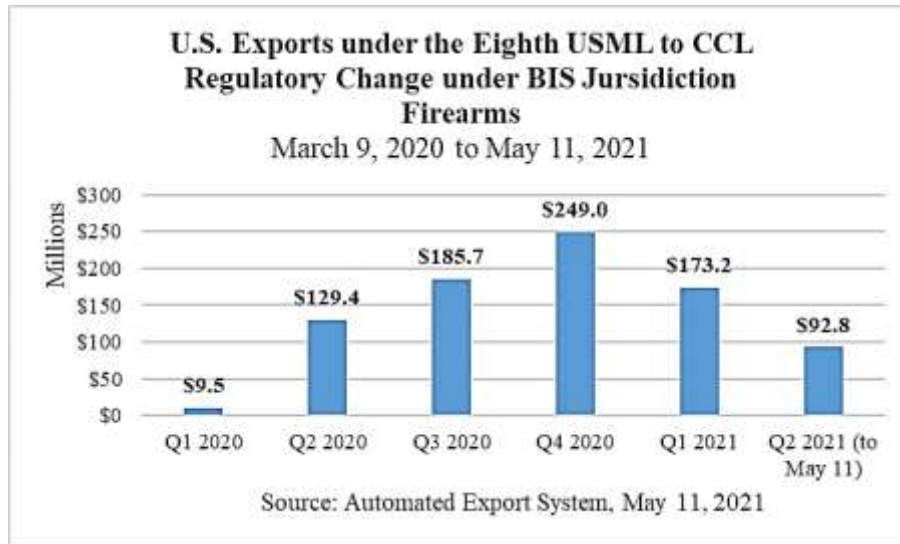
The Eighth USML to CCL Regulatory Change Firearms

March 9, 2020 to June 30, 2021

Since the eighth USML to CCL regulatory change became effective on March 9, 2020 to June 30, 2021, BIS has processed a total of 11,967 licenses for a total value of \$16.9 billion for the 17 firearm ECCNs created by this rule. BIS has approved a total of 11,322 license applications for a value of \$15.7 billion and the approval rate is 94.6%.



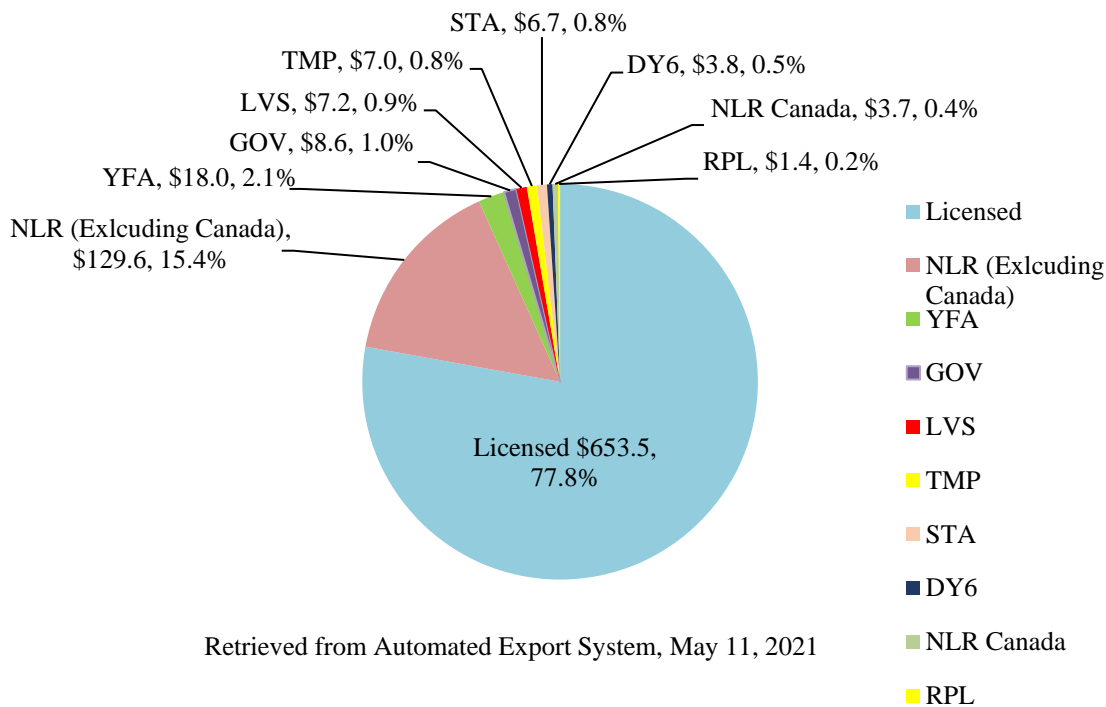
From the effective date of March 9, 2020 to May 11, 2021, U.S. exports of items in the Eighth USML to CCL regulatory change – Firearms under BIS jurisdiction totaled 35,091 shipments with a shipped value of \$839.7 million.

Of \$839.7 million in U.S. exports of firearm items under the eighth USML to CCL regulatory change under BIS jurisdiction from March 9, 2020 to May 11, 2021, licensed exports totaled \$653.5 million (77.8% of the total); no license required excluding Canada totaled \$129.6 million (15.4%) and no license required for 0A501.y subparts totaled \$18.0 million (2.1%).

BIS License Exceptions:

- STA: Strategic Trade Authorization
- RPL: Servicing and replacement of parts and equipment
- NLR: No License Required (NLR)
- GOV: Governments, international organizations, international inspections under the Chemical Weapons Convention, and the International Space Station
- TMP: Temporary imports, exports, reexports, and transfers (in-country)
- LVS: Shipments of limited value
- DY6: NLR for subparts to ECCN 0A501 and 600-series and 9x515.y subparts
- YFA: NLR for 0A501.y subparts
