

Analysis of U.S. Trade with France, 2022

Summary

Imports and exports reported by U.S. Census Bureau¹

In 2022, both U.S. exports to France and imports from France grew for a second year in a row. U.S. exports totaled \$46.0 billion, an increase of 53.9% (\$16.1 billion), and U.S. imports totaled \$57.3 billion, an increase of 14.3% (\$7.2 billion). The trade deficit was \$11.3 billion, decreasing 44.3% (\$9.0 billion) from 2021.

In 2022, 2.2% of total U.S. global exports of \$2.1 trillion were exported to France and 1.8% of total U.S. imports of \$3.2 trillion from all countries were imported from France.

In 2022, \$1.3 billion of U.S. exports of Art, Collectors' Pieces, Antiques to France represented 11.5% of U.S. global exports of those commodities.

In 2022, \$13.7 billion of U.S. imports of Chemicals, Plastics, Rubber, And Leather Goods from France constituted 2.9% of the total U.S. imports of those commodities.

BIS export data²

In 2022, U.S. exports to France shipped under a BIS license exception totaled \$393.6 million, an increase of 23.0% from \$320.0 million in 2021.

In 2022, the top license exception utilized under the Export Administration Regulations (EAR) was Encryption Commodities & Software (ENC). Exports made with an ENC license exception totaled \$251.7 million, accounting for 64.0% of exports to France made under license exceptions. This was followed by Temporary Imports, Exports, Reexports, and Transfers (TMP) (\$65.6 million; 16.7%), and Servicing and Replacement Of Parts and Equipment (RPL), (\$31.4 million; 8.0%).

BIS licensing data³

In 2022, the number of export license applications for France, excluding applications for deemed⁴ exports, amounted to 2.4% of total applications worldwide.

In 2022, for applications involving commodities, software, and technology (excluding deemed exports of technology and source code to French nationals in the U.S. or made as deemed reexports in a third country), BIS reviewed 945 export license applications valued at \$2.1 billion for France. Of these applications, BIS approved 860 applications for France valued at \$1.98 billion with an approval rate of 91.0%. BIS denied four license applications for France. The remainder were returned without action (RWA).

In 2022, BIS reviewed 17 applications for deemed exports involving French nationals, representing 1.2% of total deemed export applications worldwide. Sixteen of these applications were approved and one was returned without action (an approval rate of 94.1%).

In 2022, the top approved Export Control Classification Numbers (ECCNs) on licenses for France were 9A610 for Military Aircraft and Related Commodities with 216 approvals, followed by 0A501 for Firearms (except 0A502 shotguns) and Related Commodities as follows with 98 approvals, and 3A611 for Military Electronics with 94 approvals.

In 2022, the average processing time for applications involving France was 23 calendar days.



I. Total U.S. trade in goods with France⁵

In 2022, both U.S. exports to France and imports from France grew for a second year in a row. U.S. exports totaled \$46.0 billion, an increase of 53.9% (\$16.1 billion), and U.S. imports totaled \$57.3 billion, an increase of 14.3% (\$7.2 billion). The trade deficit was \$11.3 billion, decreasing 44.3% (\$9.0 billion) from 2021.



In 2022, the level of U.S. exports to France and U.S. imports from France in goods, merchandise, and commodities exceeded the prior five-year average level by value (not adjusted for inflation), while the trade deficit fell below the prior five-year average.

In 2022, of \$46.0 billion in U.S. exports to France, the top commodity sectors were Oil, Minerals, Lime, and Cement (32.7% of the total exports to the country), Transportation Equipment (20.0% of such total), and Machinery and Mechanical Appliances (14.4% of such total).

In 2022, of \$57.3 billion in U.S. imports from France, the top commodity sectors were Chemicals, Plastics, Rubber, and Leather Goods (23.8% of the total U.S imports from the country), Machinery and Mechanical Appliances (20.0% of such total) and Agricultural Products (14.1% of such total).

In 2022, 2.2% of total U.S. global exports of \$2.1 trillion were exported to France and 1.8% of total U.S. imports of \$3.2 trillion from all countries were imported from France.

Exports

In 2022, \$1.3 billion of U.S. exports of Art, Collectors' Pieces, Antiques to France represented 11.5% of U.S. global exports of those commodities. Additionally, \$15.0 billion of exports of Oil, Minerals, Lime, and Cement represented 3.9%, and \$9.2 billion of Transportation Equipment represented 3.8% of U.S. global exports of those commodities.

Imports

In 2022, \$13.7 billion of U.S. imports of Chemicals, Plastics, Rubber, and Leather Goods from France constituted 2.9% of the total U.S. imports of those commodities. Additionally, \$11.5 billion of imports of Machinery and Mechanical Appliances represented 1.2%, and the \$8.1 billion of imports of Agricultural Products represented 3.7% of the global U.S. imports of those commodities.

II. U.S. Exports to France Subject to BIS Export Controls⁶

In 2022, of the \$46.0 billion⁷ in U.S. exports to France:

- \$169.9 million, or 0.4% of the total value, were exported under a BIS license;
- \$393.6 million, or 0.9% of the total value, were exported under a BIS license exception;
- \$12.6 billion, or 27.3%, were exported under No License Required (NLR) reporting an ECCN⁸;
- \$12.8 million, or 0.03%, were exported under NLR for 600-series. y subparagraph items⁹;
- \$0.4 million, or 0.001%, were exported under NLR for 0A501. y subparagraph Firearms items. 10

For comparison, globally:

- 0.4% of U.S. exports by dollar value were exported under a BIS license;
- 0.8% were exported under a BIS license exception;
- 9.6% of exports were exported under NLR reporting an ECCN;
- 0.02% of exports were exported under NLR for 600-series. y subparagraph items;
- 0.001% of exports were exported under NLR for 0A501. y subparagraph Firearms items.

In 2022, U.S. exports to France made under a BIS license exception totaled \$393.6 million, an increase of 23.0% from \$320.0 million in 2021.



In 2022, the top license exception, Encryption Commodities & Software (ENC), totaled at \$251.7 million (64.0% of all license exceptions for France), followed by Temporary Imports, Exports, Reexports, and Transfers (TMP), totaled at \$65.6 million (16.7%), and Servicing and Replacement of Parts and Equipment (RPL), totaled at \$31.4 million (8.0%).







III. BIS Licensing Involving France¹¹

In 2022, the number of export license applications for France, excluding applications for deemed exports and reexports, amounted to 2.4% of total applications worldwide.

In 2022, for applications involving commodities, software, and technology (excluding deemed exports and reexports of technology and source code to French nationals in the U.S. or in a third country), BIS reviewed 945 export/re-export license applications valued at \$2.1 billion for France, compared to 39,045 applications worldwide valued at \$335.9 billion. BIS denied four license applications. BIS approved 860 applications valued at \$1.98 billion with an approval rate of 91.0%, compared to 34,068 approvals worldwide and valued at \$226.1 billion with an approval rate of 87.3%.



In 2022, BIS reviewed 17 applications for deemed exports or reexports involving French nationals, representing 1.2% of total deemed export or reexport applications worldwide. BIS approved 16 of these applications and returned one without action (an approval rate of 94.1%).

In the last five years, there were no denied applications for deemed exports or reexports involving French nationals.
