
Statistics of the U.S. Export Control Reform (ECR) Exports¹

October 15, 2013 to September 30, 2015


Since the 1st ECR Transition Rule became effective on October 15, 2013, military items in 15 categories of the United States Munitions List (USML) that do not warrant control on the USML have transitioned to the Commerce Control List (CCL) under President Obama's Export Control Reform Initiative. These items are classified with 600-series and 9x515 Export Control Classification Numbers (ECCNs).

From October 15, 2013 to September 30, 2015, the U.S. exported 600-Series and 9x515 items approximately over 159.00 transactions for \$6.2 billion.


