
License Applications and Exports

The Second USML to CCL Regulatory Change Vehicles and Vessels

January 6, 2014 to December 31, 2017


The license applications for items in categories VI (Vessels), VII (Vehicles), XIII (Auxiliary Military Equipment) and XX (Submersible Vessels) of the United States Munitions List (USML) have declined 40.7% from an average of 484 to 287 per month through December 31, 2017. The average monthly drop of 197 license applications is the result of certain items transitioning to the Commerce Control List (CCL).

Since the second USML to CCL regulatory change became effective on January 6, 2014, the average number of BIS license applications for the nineteen 600-Series items created by this rule is 118 per month through December 31, 2017. The approval rate is 83.9%.

From January 6, 2014 to December 31, 2017, U.S. exports of items in the second USML to CCL regulatory change – Vehicles and Vessels items (0y606, 8y609, 8y620 and 0y617) under BIS jurisdiction totaled 32,073 shipments for \$1.4 billion.


U.S. Exports under the Second USML to CCL Regulatory Change under BIS Jurisdiction



Of the \$1.4 billion in U.S. exports of 600-series items in the second USML to CCL regulatory change under BIS jurisdiction from January 6, 2014 to December 31, 2017, licensed exports totaled \$873.5 million (61.6% of the total); No License Required (NLR) for .y 600-series items totaled \$244.6 million (17.3%); and NLR for 600-series items to Canada totaled \$125.0 million (8.8 %).

NLR: No License Required

Weapons Convention and the International Space Station

STA: Strategic Trade Authorization

RPL: Servicing and replacement of parts and equipment

TMP: Temporary imports, exports, reexports, and transfers (in-country)

LVS: Shipments of limited value
