
## **The Sixth USML to CCL Regulatory Change Toxicological Agents** December 31, 2016 to March 31, 2019

Since the sixth USML to CCL regulatory change became effective on December 31, 2016, BIS has approved a total of 314 license for a value of \$94.3 million. The average number of BIS license applications for the eight 600-Series items created by this rule is 14 per month through March 31, 2019. The approval rate is 85.3%.


From the effective date of December 31, 2016 to March 31, 2019, U.S. exports of items in the sixth USML to CCL regulatory change –Toxicological Agents items (1x607) under BIS jurisdiction totaled 638 shipments for \$44.9 million.

Of the \$44.9 million in U.S. exports of 600-series items in the sixth USML to CCL regulatory change under BIS jurisdiction from December 30, 2014 to March 31, 2019, licensed exports totaled \$25.3 million (56.3% of the total); No License Required for .y 600-series items totaled \$9.7 million (21.7%); and No License Required to Canada totaled \$7.3 million (16.3%).

NLR: No License Required

STA: Strategic Trade Authorization

GOV: Governments, international organizations, international inspections under the Chemical Weapons Convention, and the International Space Station
