
Licensing Statistics of 600-Series and 9x515 Items

October 15, 2013 to September 30, 2019

Since October 15, 2013, certain items that were determined not to warrant control on the United States Munitions List (USML) have moved to the Commerce Control List (CCL), creating 600-series ECCNs and 9x515 ECCNs.


BIS Average Monthly Applications by USML to CCL Regulatory Changes

In the last two years, the monthly declines of license applications for the items in the 18 categories of the USML have been stable, at an average of 52.1% decline, thus, the Directorate of Defense Trade Controls (DDTC) of the U.S. Department of State has stopped reporting licensing statistics for this report. In order to continue to show the licensing trends of impact of the USML to CCL regulatory changes, this report uses the licensing data last reported from DDTC as September 30, 2018.

From October 15, 2013 to September 30, 2019, BIS has processed a total of 80,957¹ applications for 600-series and 9x515 items. Of these, 75,619 applications were for 600-series items and 5,338 were for 9x515 items.


Of 75,619 applications for 600-series items:

- Approved applications were 67,862, 89.7% of the total applications;
- Returned without action (RWA) were 7,558, 10.0% of the total; and
- Denied applications were 199, 0.3% of the total.

Of 5,338 applications for 9x515 items:

- Approved applications were 4,472, 83.8% of the total applications;
- Returned without action (RWA) were 769, 14.4% of the total; and
- Denied applications were 97, 1.8% of the total.


BIS License Applications for 600-Series and 9x515 Items by Total Count Effective Date to September 30, 2019



 $^{^1}$ Note: This number for the total applications is slightly smaller than the sum of all applications by each rule because license applications containing multiple ECCNs may be associated with more than one regulatory change. For instance, a single application containing 9A 610 and 0A 606 items would be counted in both the $1^{\rm st}$ rule column and the $2^{\rm nd}$ rule column.

BIS License Applications for 600-Series and 9x515 Items by Year


Effective Date to September 30, 2019

BIS License Applications for 600-Series and 9x515 Items by Decisions

From October 15, 2013 to September 30, 2019, BIS has processed applications for 600-series and 9x515 items for a value of \$299.9 billion. Of these, \$174.0 billion for 600-series items and \$125.9 billion for 9x515 items.

Of \$174.0 billion for 600-sereis items:


- Approved applications valued at \$159.5 billion, 91.7% of the total application value;
- Returned without action (RWA) valued at \$13.9 billion, 8.0% of the total; and
- Denied applications valued at \$590.3 million, 0.3% of the total.

Of \$125.9 billion for 9x515 items:

- Approved applications valued at \$124.6 billion, 99.0% of the total application value;
- Returned without action (RWA) valued at \$1.2 billion, 1.0% of the total; and
- Denied applications valued at \$69.3 million, 0.06% of the total.

BIS License Applications for 600-Series and 9x515 Items by Value


Effective Date to September 30, 2019 \$million



In the last 13 months from September 2018 to September 2019, the average monthly BIS license approvals for all ECCNs are 2,429, indicating an increase of 42.9% from the average monthly approvals of 1,700 during the fiscal year 2012 to 2013, prior to the first regulatory change from the USML to the CCL became effective on October 15, 2013:

- For 600-Series items, the average monthly license approvals are 969;
- For 9x515 items, the average monthly license approvals are 62; and
- For legacy ECCNs, the average monthly license approvals are 1,398.


Trends in BIS Approved License Applications



Of the total 67,862 BIS approved licenses for 600-series items from October 15, 2013 to September 30, 2019, 50,093 (73.8% of the total approved licenses) were issued for exports to the top 15 destinations by license count. The top destinations were Japan with 8,537 approved licenses (12.6% of the total); the United Kingdom with 7,895 (11.6%), and South Korea with 4,044 (6.0%).

Of the total 4,472 BIS approved licenses for 9x515 items from October 15, 2013 to September 30, 2019, 4,324 (96.7% of the total approved licenses) were issued for exports to the top 15 destinations by license count. The top destinations were India with 894 approved licenses (20.0% of the total); Japan with 777 approvals (17.4%), and France with 515 approvals (11.5%).
