Additional Information

To find out of your non-U.S.-made item is subject to National Security (NS) controls, you must find out if there is a NS license requirement for the Non-U.S.-made item to the intended destination.

- 1. Find the classification (Export Control Classification Number ECCN) for your non-U.S.-made item. For more information about classifying a product go to the BIS classification guidance page http://www.bis.doc.gov/index.php/licensing/commerce-control-list-classification
- 2. Look in the License Requirements section of that ECCN, where you will find a table that lists the license requirements, see below for an example.

- 3. If the subparagraph, for example 3A001.b.3, is listed under an NS row, then your non-U.S.-made item has a NS license requirement. 3A001.b.3 might be NS:1, depending if the item meets the criteria listed for NS:1. However, 3A001.b.3 is definitely is NS:2, because NS:2 applies to the entire entry.
- 4. If there is an "X" under the applicable NS Column 1 or NS Column 2 on the Commerce Country Chart in Supplement No. 1 to part 738, then your non-U.S.-made item is controlled for NS reasons.

For example: If you have a 3A001.b.3 that is not a MMIC, then you have a NS Column 2 license requirement. If that 3A001.b.3 non-MMIC were being exported to Angola, then the 3A001.b.3 non-MMIC would be controlled for National Security reasons, because there is an X at the intersection of the Angola row and the NS:2 column. However, if you were exporting to Argentina instead, the item would not be controlled for NS reasons, because there is no X at the intersection of the Argentina row and the NS:2 column.
